CURRO TERMS OF USE SOCIAL MEDIA

18 JULY 2013

This policy outlines the terms of use related to the posting of content on any Curro Social Media pages.

Followers and users are encouraged to share, comment and post on the Curro Social Media pages. By posting on an official Curro Social Media page, you agree to the Terms and Conditions of the Social Media platform and you agree to abide by the Curro Terms of Use as set out by Curro.

1. All content and commentary must be relevant and respectful to Curro, the Curro brand, Curro employees, parents and learners.
2. Curro administrators will, to the best of their ability, answer all queries posted to Curro Social Media pages and are generally online and available from 9:00am to 4:00pm every week day.
3. Curro reserves the right to untag Curro from any posts, photographs and associations that are deemed inappropriate.
4. Do not share any personal information on any Curro Social Media pages. Please contact Curro directly on info@curro.co.za.
5. By commenting on or posting to an official Curro Social Media page, you acknowledge that you are aware of the age restrictions of the various Social Media platforms and that you are not under age. If this is not the case and Curro is made aware of this, the post will be removed from the page.
6. All Curro employees using official Curro Social Media pages must adhere to the guidelines. Breach of this policy may result in disciplinary action or termination of contracts.
7. The following will not be tolerated on a Curro Social Media page.
 - Offensive language, hate speech, discriminatory, defamatory, vulgar, harmful or explicit content.
 - Content which amounts to invasion of privacy.
 - Language that is disrespectful to any race/ethnicity, religion, gender, nationality or political beliefs.
 - Content or links that are sexually explicit, harmful to children or includes products not suitable for any person under the age of 18.

Such content will be removed from the Curro Social Media page.

8. Posts that contain the following will be removed from the Curro Social Media page:

- Links containing spam that are intended to cause technical disruptions to the page or containing viruses or programs that could damage the operation of other users' computers.
- Any surveys, contests, pyramid schemes, chain letters, spam or any duplicative or unsolicited messages, commercial or otherwise.
- Links used to direct users to other sites, blogs or Social Media pages.
- Content in violation of intellectual property rights and confidential, proprietary business information.
- Harvesting or otherwise collecting information (data) about other users, including contact details.
- 'Trolling' (false identities) for the purpose of misleading others or deliberately disrupting discussions.
- Fraudulent, deceptive, misleading or unlawful posts/commentary.
- Harassing, stalking, threatening or personally attacking other users.
- Violation of any law or regulation.
- Anything to do with a legal issue, legal case or attorneys. This includes legal action involving Curro, soliciting individuals to engage in legal action against Curro or offering other legal advice.
