GENERAL

1. School fees

School fees for 2026 include the following:

- Group 4 to Grade R breakfast, lunch and afternoon snack; full-day until 17:30
- Holiday care

School fees for 2026 exclude the following:

- Stationery that may be required
- Entrance fees, travel costs, accommodation and food for school camps and sports trips, unless otherwise advised by the school
- Therapists' and psychologists' fees
- School photos
- Welcome pack
- Elective on-site extramural activities

School fees and swimming lessons are split over 12 months of the year to provide a standard amount monthly to accommodate a monthly debit order and these are NOT charged according to the number of days attended. Whilst there will be very little teaching during holiday months, the charge remains an annual fee divided evenly over 12 months. Fees will not be calculated pro rata.

2. Termination of enrolment

Parents/Guardians may terminate the admission and enrolment of a learner after the commencement of the first day of the school year by providing the school with at **least 3 (three) calendar months'** written notice of termination.
