GENERAL

1. School fees

School fees for 2024 include the following:

- Sport (excluding tours)
- Groups 3 to 5 and Grade R breakfast, lunch and afternoon snack; full day until 17:30

School fees for 2024 exclude the following:

- The e-learning device (tablet) and any insurance, maintenance or other costs relating to the device
- Some textbooks and learning materials (including the cost of e-books)
- School uniforms
- Additional stationery that may be required

- Entrance fees, travel costs, accommodation and food for school camps and sports trips, unless otherwise advised by the school
- Therapists' and psychologists' fees
- Individual music tuition

2. Aftercare fees

Aftercare fees for 2024 include the following:

- Supervision
- Limited homework support

Aftercare fees for 2024 exclude the following:

- Specialised subject and homework support

School fees, aftercare, swimming lessons, art and drama fees are split over 12 months of the year to provide a standard amount monthly to accommodate a monthly debit order and these are NOT charged according to the number of days attended. Whilst there will be very little aftercare and teaching during holiday months, the charge remains an annual fee divided evenly over 12 months. Fees will not be calculated pro rata.

3. E-learning devices (tablets)

E-learning devices (tablets) will be utilised by all learners from Grade 4 to Grade 7.

This will have the following impact on you:

- If your child is in Grade 4 to Grade 7, you will be responsible for purchasing an e-learning device (tablet) for your child to use. The school will provide you with details and the minimum specifications required for the device.
- You will be responsible for the insurance and general maintenance and care of the device.

The following costs associated with the use of e-learning devices (tablets) are included in the school fees:

- Access to Wi-Fi and Internet at the school
- Access to a school email account
- Access to an interactive communication platform with teachers
